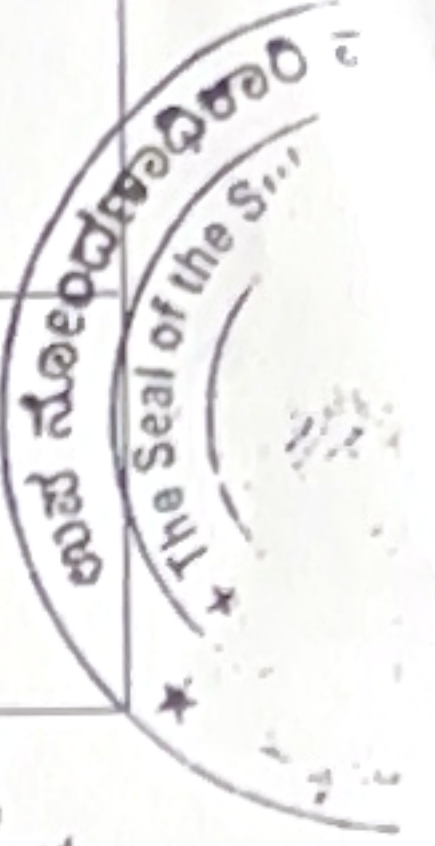

- l) To organize sports events, sports, school, adventure activities and any other similar activities for the benefits of the youths, women, children etc.



- c) **AMENDMENT CLAUSE:** No amendment to the Association, Bye-laws/Rules & Regulations, shall be made which may prove to be repugnant to the provisions of Sections 2(15), 11, 12, 12A and 80G of the Income-Tax Act 1961 as amended from time to time. NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.

- e) **CLAUSE:** The Association formed shall be IRREVOCABLE.
- f) **CLAUSE:** The benefits of the Association shall be open to all irrespective of Caste, Color, Creed or Religion.
- g) **CLAUSE:** The Funds and the Income of Association shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the Members by way of Profit, Interest, Dividends etc.,
- h) **CLAUSE:** The objects/activities of religious nature require deletion.

4. The Trustees shall have a Managing Trustees, Secretary, Treasurer and those elected amongst them from time to time. Whose office shall be for a period of three years, the following Trustees will be Managing Committees.

- Raise loan secured or unsecured from any Financial Institutions, Nationalized Banks or any other Banks, Co-Operative Societies or from individuals etc.,

All powers of administrations, control and authority in respect of the Trust properties and fund shall invest in the board of Trustees for the benefit of and achievement of the objects and purpose of the Trust.

6. MANAGERMENTS:

- The Trustees shall meet as often as possible but not less than three times in a year for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- At all meeting of the Trustees, Two members will form of quorum.
- At all meeting of Trustees, Managing Trustees or his absence the joint Managing Trustee or in their absence any other Trustee shall be the chairman and all decisions of the Trustees shall be by majority vote, and the chairman shall have a casting vote incase of equality of votes.

- g) Incase of any difference of opinion between the Trustees in any matter connected with the Trust and its administration the decision of the majority will be final and binding on all the Trustees.

7. POWERS OF THE TRUSTEES:

- a) To Manage Trust funds and collect and recover the interest, income and profits thereof and to pay there out the expenses of collection and other outgoing if any.
- b) The Trustees shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of Trust, whenever, such powers are not specifically conferred.
- c) The Trustees shall be entitled from time to time to open, maintain and operate a Bank Account or Accounts in the name of the Trust or in the name of the school or schools or institutions at such bank or banks as they may from time to time decide and may it any time pay or cause to be paid any moneys forming part of the Trust fund/School fund or the income thereof to the credit of any such account or accounts either by

- f) The Trustees at their discretion may sell any immovable property or properties which may for the time being the subjects of the Trust of these presents, with power to buy and sell the same without being responsible for any loss that may thereby be incurred and incase of such sale to execute and do all such deeds and acts for the purpose of carrying and all money accruing from any such sale be deemed to be part of the Trust estate and shall be applied accordingly.
